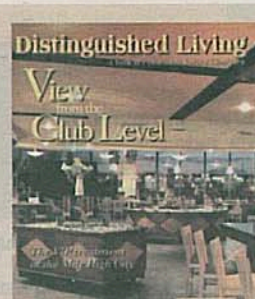

After almost a decade of fighting for home repair money, owners at Heritage Village townhome complex in Golden got more than \$3.6 million last fall.

A Jefferson County jury found the complex's builders negligent, and awarded the 63 homeowners the money to repair things such as shingles and vinyl siding that blew off in wind storms, and concrete basements and

driveways that cracked.

Homeowners may get more than \$12 million, because the jury also found the builders committed deceptive trade practices under Colorado's Consumer Protection Act.

Homeowners also found out their decks were made of lower-grade fir after being promised California redwood.

At one point in the litigation, Zurich Insurance, the insurance company for the builder, sued both the homeowner's association and the builder in federal court, said Jesse Witt, who represented the homeowners.
